Is 'Transgender' True?

A shorter version of this article will appear in the July, 2017 issue of The Lutheran Witness, the national magazine of the Lutheran Church—Missouri Synod.

"For the time will come when men will not put up with sound teaching. Instead, to suit their own lusts, they will gather around them a great number of teachers to say what their itching ears want to hear. They will turn away from hearing the truth and turn aside to man-made fictions." (2 Timothy 4:3-4)

I recently read an article about a famous inventor of medical devices who created a new machine that strengthens the "pelvic floor" of women through electrical muscle stimulation. It seems that a weak pelvic floor is an underlying cause of many female medical issues.

Although men have a similar structure, also called a pelvic floor, they are distinctly different in men and women, both in how they are designed and how they function. The article reported that as this inventor studied the female pelvic floor, he was quite surprised to discover how it is interconnected throughout the female body, in a way not found in males:

*"He'd discovered something that only a very few . . . researchers had ever seriously thought about: A woman's pelvic floor is almost unfathomably complicated, designed . . . to control and influence all sorts of bodily functions from bladder control to posture . . . The pelvic floor's health and strength affects not just obvious parts of a woman's anatomy, but also her lower back, hips, and knees."**

This is just one example of how ludicrous and unscientific it is to claim that men can "transition" to becoming women or vice versa. No matter what kind of cosmetic or even surgical changes are made, a man who claims to be a woman will never have a female pelvic floor, and a woman who claims to be a man will die with this piece of unique female anatomy in place—her body simply couldn't function properly without it.

I remember being quite surprised there were such obvious, distinct differences in male and female human skulls.

I have encountered firsthand such basic differences between the sexes myself when working as an archaeologist in the Holy Land, at an ancient Roman settlement about 30 miles from the Sea of Galilee. Because of my fair skin, I was assigned to work not in the desert sun (whew!) but in the cool, dark, underground tombs, elaborate caves cut into the rock, dating back generally to the New Testament era.

The families had a custom of allowing loved ones to "desiccate" after burial, a polite way of saying the fleshy portions would rot away, leaving only the bones. This is probably what Job is referring to, speaking of the resurrection of the body

in Job 19:25-27: *"I know that my Redeemer lives, and that in the end He will stand upon the earth. And after my skin has rotted away, yet in my flesh I will see God; I myself will see Him with my own eyes—I, and not another."*

Somewhat bizarrely from our perspective, these bare bones would then usually be consolidated into piles to make room for new burials in the family tomb. This meant that a typical tomb with a half-dozen or so "loculai," horizontal, tunnel-like shafts cut into the rock from the main room, into which bodies would be laid, would often have the skeletal remains of *dozens* of individuals, of all ages and both sexes.

In one case in a tomb I excavated, I first came across a half-dozen skulls grouped together—quite a sight! As I continued to carefully dig down I found under the skulls all the bones from these half-dozen individuals, neatly arranged in layers according to type: all the tibias layered together, then fibulas, etc. It was a somewhat unusual arrangement and I was considered by the others on our team quite lucky to find it in one of the tombs assigned to me. Having never seen a patella before—they were usually lost over the centuries in the shuffling of bones—I nearly missed the little pile of a dozen kneecaps!

Due to this intentional rearranging of the bones, as well as disturbance from animals, flooding, and other geologic action, we rarely found a complete, intact skeleton as one imagines archaeologists uncovering—there were only a few of those out of hundreds of burials we excavated—but we rather ended up with jumbled piles of hundreds of mixed-up bones.

It was extremely important to know for archaeological and anthropological reasons how many distinct individuals these bones from a given tomb represented, and of what age and sex.

Our excavation staff included a professional osteologist, or ancient bone specialist, a professor of anatomy with a PhD in the field. Under his guidance, those of us on the tomb crew would sit around camp in the evenings engaged in a massive, macabre jigsaw puzzle, piecing together as much as possible full skeletons out of the mounds of bones retrieved from each tomb.

One of the first things “Doc” taught us how to recognize is the distinct differences between male and female bones, particularly visible in the pelvises and skulls, but for an expert like him evident in many parts of the human skeleton. I must have been absent the days this was covered in biology classes, because while it made sense that the pelvises would be different to accommodate childbirth, I remember being quite surprised there were such obvious, distinct differences in male and female human *skulls*.

A study of human anatomy reveals that the differences between male and female are not superficial, but extend throughout our bodies. The changes that those who supposedly “transition” to the other sex undergo, even if done surgically or with artificial hormones, are merely superficial and cosmetic. It’s like putting Ford nameplates and logos on a Chevrolet—and then claiming it has “transitioned” to being a Ford! The two brands indeed outwardly look very much alike, there are many similarities between them, and some parts are standardized and interchangeable between the two. But, fundamentally they are each uniquely engineered, and have basic differences incorporated throughout their design and functionality.

It is the same with men and women. The Bible says simply, “*Male and female He created them*” (Genesis 1:27), and “*at the beginning the Creator made them male and female*” (Matthew 19:4). The simplicity of those statements nevertheless reveals a profound reality that today many otherwise intelligent and educated individuals, even some with medical and scientific training, seem to have forgotten. Apart from very rare genetic defects, humans from the beginning universally have been and continue to be made either male or female—not some neutral gender or mishmash of both. These two sexes are distinct and not interchangeable, and the sex of each individual is permanent and immutable. Despite absurd views some apparently have to the contrary, these are indisputable scientific facts.

It’s like putting Ford nameplates and logos on a Chevrolet—then claiming it “transitioned” to being a Ford!

Psalm 139:13-16 makes clear that the sex of an individual, irreversibly determined at the moment of conception, is part of God’s plan for that person’s life: “*For You created my inmost being; You knit me together in my mother’s womb. I praise You because I am fearfully and wonderfully made; Your works are*

wonderful, I know that full well. My frame was not hidden from You when I was made in the secret, intricately woven together as in the depths of the earth. Your eyes saw my unformed body, and all the days ordained for me were written in Your book before one of them came to pass.”

Likewise, the Lord declares in Jeremiah 1:5, “*Before I formed you in the womb, I knew you; before you were born, I set you apart.*” It almost seems that the Apostle Paul in 1 Corinthians 12:18 anticipated and refutes the claim that some humans are born the “wrong sex”: “*But in fact God has arranged the parts of the body, every one of them, just as He wanted them to be.*”

It is precisely the differences God created in the two sexes of the human race that provides humanity with some of the greatest joys and pleasure in life.


The saddest part of the “transgender” concept is that the ingenious, complimentary manner in which God designed and still creates males and females is one of the most wonderful aspects of God’s creation. It is beautifully expressed in Genesis 2:18: “*The LORD God said, ‘It is not good for the man to be alone. I will make a companion suitable for him.’*” The French have a cheekier way of saying it: *Vive la difference!*

It is precisely the *differences* God created in the two sexes of the human race that provides humanity with some of the greatest joys and pleasure in life. It is all part of God’s plan for our good. Attempts to deny or muddle those differences are a lie, robbing us of an essential aspect of our humanity. Instead of vainly trying to overthrow God’s plan, we will find happiness in embracing with gusto His design, for our individual selves and the whole human race. *Vive la difference!*

We rejoiced to celebrate the Confirmation and First Communion of Luke Elkinton and Evan Kettler on May 21.




